## Item 3: New Business Arising from Minutes

- 3.1 Evolution apparel demo (CCM and Bauer) only Bauer was available to view, as the CCM products are not in yet. The CCM products will be brought at the next meeting. Steve will follow up on the price for the hockey bag. Apparel night is scheduled for picture night.
- 3.2 Nominate & vote for a new Website and Equipment coordinator's
  - Chris Simonson announced his interest to be considered for website coordinator role, Steven Kuchirka nominated Chris Simonson, Rachelle Morgado second, all in favour.
  - Crystal Bernard announced her interest to be considered for equipment coordinator
  - Travis provided a job overview of the equipment coordinator role for Crystal Bernard
  - Crystal Reimer nominated Crystal Bernard, second by Steve Benson, all in favour.

## 3.3 Current Registration – Rachelle

- 258 kids enrolled (August 22 meeting 245 kids)
  - 26 initiations estimated 2 teams
  - 42 novices estimated 3 teams
  - 62 atoms estimated 4 teams
  - 48 peewees estimated 3 teams

- 45 bantams estimated 2 teams
- 35 midgets estimated 2 teams
- 35 kids asked for releases
- 3.4 Meeting Protocol discussion Jonathan asked if a sub group wanted to create a DMHA meeting protocol format outside the regular scheduled DMHA meeting. Steven Kuchirka suggested that we keep to the agenda to ensure we keep these meeting moving. Jonathan said he will put more focus on tabling topics for future meetings.
- 3.5 Jonathan presented the new initiation program mandated by Hockey Alberta: <u>https://www.hockeyalberta.ca/uploads/source/Initiation/2017-</u> <u>18 Initiation Program Standards.pdf</u>. DMHA will now comply with Hockey Alberta initiation program. In addition, there will be changes to the Hockey Alberta Novice program next year. Steven Benson will contact our DMHA initiation coordinator and provide her all the Hockey Alberta initiation program requirements and assist her with any support she needs to implement the changes.
  - Crystal Bernard will talk to the town to find out if we can store the dividers. Steve Benson will find out when the dividers will be in and ready to be picked up from Drayton Valley.

## Item 4.1 President Report

- a. Executive Member Pledges follow-up Chris Simonson, Crystal Bernard
- b. CMHA info Calmar is looking to combine their bantam players with Thorsby.
  - DMHA is still waiting to hear about the availability for Calmar ice. Calmar offered 5 pm ice but DMHA would have a hard time getting coaches on the ice in Calmar at 5 pm.
  - DMHA will accommodate as many peewee kids as possible.
  - DMHA currently has 45 kids register for bantam and is over the recommend max number of 38 – includes 4 goalie's. Some questions occurred on how to handle DMHA kid's overage. DMHA will follow the existing 9.3.1 Rules and Regulation in the event that the number of registrations is not viable for the operations of a team.
  - Calmar was informed that they need to release the kids and provide the forms to the DMHA registrar before the kids are able to skate on the Devon ice.
  - DMHA players who have a received an N.T.O. (Notification of Tryout Form) signed by the president, may participate in the DMHA conditioning camps ONLY prior to the commencement of their AA or AAA tryouts. Once these Tryouts begin, players must not skate in Devon until they have been released from the association where they are trying-out.
- c. Action log reviewed and update
  - d. Ron Oscroft from Quickstart will be teaching the September 23 and 24 checking clinics. Darcy will draft the details of who should attend and what the processes will be for a notice to be posted on DMHA website by September 12, 2017.

**Note**: A parent requested in writing to have his initiation son try out for novice. The executive reviewed the 8.2.2 DMHA Rule and Regulations and approve the request following the below rule:

8.2.2. Players of a lower category may try out with the next highest category's representative team by submitting a written request to the DMHA President prior to the start of evaluations. If the request is approved by DMHA the player may participate in evaluations at the requested higher category. If the Devon player succeeds in making the team they will be allowed to play provided they do not bump another Devon player in that category who would thus be unable to play on a Devon team.
